

Southern Newfoundland Club Judging Criteria – Water

Introduction:

- Submitted a written application to Working Section Sub-Committee detailing previous experience and reasons for wishing to judge
- Must have read & understood the Test Regulations
- Keep own record judging experience
- Must apply in writing to the SNCWSC for consideration for promotion from either junior to senior or to higher levels.
- o Judging & stewarding may be at NC, NNC & SNC events
- Judges & Stewards are expected to attend training days as organized
- Promotion from Novice to Senior or to next level is subject to approval by the majority at a SNCWSC meeting

Section A Qualifications:

- Stewarded Sections A at 2 separate events
- Handled a dog in Sections A
- o First judging appointment to be with a Section C judge or above
- o Conduct judges briefing (entrants & Stewards) at novice level at one event.
- Judge a minimum 20 dogs at 2 events as novice judge before being eligible for promotion to senior judge
- o Conduct judges briefing (entrants & Stewards) at senior level at one event

Section B Qualifications:

- Stewarded Section B at two events
- o Judged a minimum 20 dogs at 2 events as senior judge at Section A
- o Conduct judges briefing (entrants & Stewards) at novice level at one events
- Judge a minimum 20 dogs at 2 events as novice judge before being eligible for promotion to senior judge
- o Conduct judges briefing (entrants & Stewards) at senior level at one event

Section C Qualifications:

- Stewarded Section C at two events
- o Judged a minimum of 20 dogs at 2 events as senior judge at Section B
- o Conduct judges briefing (entrants & Stewards) at novice level at one event
- Judge a minimum of 15 dogs at 2 separate events as novice judge before eligible for promotion to senior judge
- o Conduct judges briefing (entrants & Stewards) at senior level at one event

Section D Qualifications:

- o Stewarded or handled a dog in Section D at three events
- o Judged a minimum of 15 dogs as senior judge at Section C
- o Conduct judges briefing (entrants & Stewards) as Novice Level D
- o Must judge as Novice at 1 event before eligible for promotion to senior judge

Section E Qualifications:

- o Stewarded or handled a dog in Section E at three events
- o Judged a minimum of 10 dogs in Section D
- o Conduct judges briefing (entrants & Stewards) at novice level at one event
- o Must judge at 1 event as novice E judge before eligible for promotion to senior judge

Stewards

- No Steward is permitted to drive the boat without R.Y.A. powerboat 2, relevant experience and insurance
- o Stewards must attend judges and stewards briefing for the relevant section
- o Stewards must have trained a dog and handled a dog in Section A
- o Stewards must have read & understood the Test Regulations
- o Stewards must start at Section A and work through each Section
